When using the box for the first time:</p> <ol style="list-style-type: none"> 1. Remove the cover, 2. Permanently remove the seal, 3. Thread the central wipe through the hole in the cover with clean hands and 4. Replace the cover. 5. Use the wipe on the equipment. 6. Leave on for 30 seconds to 15 minutes according to the antibacterial activity required. 7. Leave to dry in the open air. 8. Do not rinse. 9. Close the flap after each use to prevent the wipes from drying out.
